

THE MAIN EVENT RULES

The Main Event Show will open on January 09, 2010. Vendors will be required to be in their spaces within 24 hours of the opening of show or, vendor space will be resold without refund or rollover to vendor.
The Main Event may accept a Vendor Late Arrival Form with management approval.

You are allowed one day prior to show to set up for FREE.
Vendors arriving before January 8th are required to pay normal (off show) rent.
\$450.00/month; \$225.00/2weeks; \$125.00/1week; \$20/day NO EXCEPTIONS!!

Vendors are required to call The Main Event office 24 hours in advance prior to arrival.
Upon arrival The Main Event management MUST guide vendor into their space.
There will be NO vendor arrival/move in after 5:00 p.m.

Any broken utilities will be charged to the vendor at the rate of \$100.00 minimum each breakage.

Speed limit on The Main Event property is 5 mph, speeding violators will be asked to leave The Main Event after 2 warnings.
No carpets or merchandise will be allowed in the FIRE LANE. NO EXCEPTIONS.

No trailers will be left in the parking lots.
Off space trailer storage will be available to vendors for \$25.00 per month.

Vendors will post booth number in plain sight of your booth.

There will be NO resale of ANY vendor. There will be NO sharing of space by more than ONE vendor.

There will be no moving from space to space. Vendors must stay within their marked areas.
Once your space is vacated, it will be resold by The Main Event management.

A service fee of \$200.00 will be assessed if a vendor cancels any space prior to Oct. 1st 2009.
If vendor cancels any space after Oct. 1st 2009 there will be absolutely no refunds or rollovers.
There will be a \$35.00 service charge on all returned checks.

Vendors are not allowed to submit a forwarding address change to the Main Event PO BOX.
Vendors are allowed to receive ONE large envelope each week.
To ensure proper delivery, vendors name and space # must be on envelope.

No vehicle traffic allowed on the ground between 9am & 5pm unless approved by the manager.

All vehicles **MUST** be REMOVED from fire lanes by 8:00 a.m. each day.
No vehicles are permitted to be in a fire lane at ANY time.

Vendors may not exceed 500 watts of electricity. Any other use of power must be approved by management.

NO PROBLEM DOGS ALLOWED! All dogs will be kept on a leash at all times, and every owner is responsible for cleaning up after their own animals. Failure to do so could result in loss of selling space.
Please **DO NOT** leave pets unattended. All cats must be kept in owners booth.

No parking in empty spaces. All vendors will be required to stock their spaces before 9:00 am or after 5:00 pm.

The Main Event does not accept liability of vendors on show grounds.
Vendors will accept liability for their own space and/or vehicles.
Vendors must break down all cardboard boxes prior to disposal.

Upon departure, vendors will remove ALL debris from their SPACE.

LAST DAY TO RESERVE YOUR SPACE IS JANUARY 26TH, OR IT WILL GO FOR SALE TO ANY PERSON.
Vendor's Permits & AZ Tax Permits are obtainable through Quartzsite Town Hall and are the responsibility of the Vendor
